#### 4. FIRST AID MEASURES

# 6. ACCIDENTAL RELEASE MEASURES

**Emergency Procedures:** Personnel to wear appropriate personal protective equipment and clothing to minimise exposure. Remove all sources of ignition. Stop leaks where safe to do so. Ventilate area. Use inert absorbent onto spillage to avoid spillage from entering drains or waterways. Use non sparking tools to collect material, and place in to labelled containers. Dispose of waste materials in accordance with local and national regulations. If spillage enters waterways contact the Environmental Protection Authority or local water authority.

#### 7. HANDLING AND STORAGE

**Precautions for Safe Handling:** Use in a well ventilated area. Wear appropriate protective equipment and clothing to avoid inhalation of fumes or mist, contact with skin and eyes. Containers not in use should be closed. Do not smoke. Always wash hands after handling and prior to eating, drinking, smoking or using the toilet.

**Conditions for Safe Storage:** Classified as a Class C2 (COMBUSTIBLE LIQUID) for the purposes of storage and handling. Store in a cool, well ventilated area away from heat and other sources of ignition, oxidising agents, foodstuffs, and out of direct sunlight. Keep containers securely sealed and protect against damage.

#### 8. EXPOSURE CONTROLS/PERSONAL PROTECTION

**National Exposure Standards:** No exposure standard has been established, however, the TWA National Occupational Health and Safety Commission (NOHSC) exposure standard for oil mist is 5 mg/m³. As with all chemicals, exposure should be kept to the lowest possible level.

**Engineering Controls:** Use in well ventilated areas. Where ventilation is inadequate, a local exhaust ventilation system is required.

**Eye Protection:** Safety glasses with side shields, goggles or full face mask as appropriate. Individual circumstances will dictate the final choice of protection.

**Hand Protection:** Use gloves of an impervious nature. Individual circumstances will dictate the final choice of protection.

Body Protection: Suitable protective clothing to protect areas of possible exposure from splashing.

**Respiratory Protection:** Normally not required, however if mists or vapours are generated in a poorly ventilated area an approved respirator with a replaceable vapour/mist filter is recommended.
